## “RLPC PLAYER” Service Agreement

### The Roude Léiw Polo Club Asbl (RLPC)

- offers the “RLPC PLAYER” the right to participate during all club chukkers on the polo fields of the Roude Léiw Polo Club in Luxembourg-Merl
- offers the “RLPC PLAYER” the right to do stick & ball at any time during the polo season on the polo fields of the Roude Léiw Polo Club in Luxembourg-Merl (only under the condition that the polo field is practicable; please contact the president in case of doubt to confirm that the field is open for S&B!)
- invites the “RLPC PLAYER” to their events (polo tournaments, social events, travel events, etc.) per email
- informs the “RLPC PLAYER” about all news per newsletter
- offers the “RLPC PLAYER” the right of access to the polo fields of the Roude Léiw Polo Club in Luxembourg-Merl
- offers the “RLPC PLAYER” the right to use the premises of the RLPC for a private event with their personal invitees once per year, upon request and in agreement with the board of the RLPC in regards to date and type of event

### The “RLPC PLAYER”

- pays an annual fee of 2 500 Euro (valid for one calendar year)
- can cancel this agreement at any time of the year, without any notice period, without the right of reimbursement of any paid fees for the running calendar year

**Validity:** The RLPC PLAYER Service Agreement becomes valid once the RLPC received the duly signed application form in person, by scan emailed to [info@poloclub.lu](mailto:info@poloclub.lu) or by regular mail at below mentioned address, the annual fee of 2 500 Euro has been credited to the below mentioned IBAN number and a board member of the RLPC has confirmed the agreement by email to the RLPC PLAYER.
